Information, Instruction and Checklist (Please read this before submitting documents for Grant)

Information and Instruction

- 1. The Fund is for the exclusive use and purpose Oconee County Habitat for Humanity Homeowners and their family members of the Habitat household.
- 2. No individual or person within their household, will be considered if they are past due on their mortgage.
- 3. The Fund is non-discriminatory regarding race, religion, ethnic background, age or gender.
- 4. A REQUEST FORM with key information will need to be filled out each period (Semester, Quarter or Session) with the nature of the continuing education, general information about the homeowner, the student (if different) the institution, the beginning and ending dates of the term, specifically the degree, certification or specialization being sought and when graduation or completion is expected. We have provided you with a REQUEST FORM for making this information clear to the Education Committee that will be deciding your request.
- 5. The Fund is for the sole purpose of financial support of:
 - a. Up to \$1000 per semester or \$500 per quarter of continuing education for post High School studies and
 - b. Up to \$350 towards a General Education Diploma (GED)
- 6. A DETAILED EXPENSE SHEET for payments up to these amounts (\$1000/\$500/\$350) based on actual expenses for tuition, room, board, books and transportation. Expenses will be shown on this sheet with receipts attached. If at the time of submission, a receipt has not been obtained, an estimate can be made and a receipt for that expense will be required with the next submission. EXCEPTION: Transportation costs up to \$50/semester or \$25/quarter will not require a receipt. Please use the DETAILED EXPENSE SHEET attached for the request of funds.
- 7. Grants currently to be distributed are as follows:
 - a. Post High School up to \$1000/semester or up to \$500/quarter.
 - b. GED up to \$350/session or exam provided the 1st \$10 is paid by the participant.
- 8. A grade of at least "C" will need to be obtained in order for the participant to continue to receive payments in the future. If the participant receives a grade less than "C" (D, F or Fail), then the following remedies are available to receive future payments:
 - a. Retake the course at the individual's expense and present a grade of "C" or better or
 - b. Repay the fund the money for the course (this will require an actual payment back to Habitat for the course as opposed to reduction of future funds).
- 9. Funds are to be used for any accredited online or campus classes. The recipient must provide documentation of accreditation to OCHFH, if requested.
- 10. All requests MUST BE mailed (NO EMAILS) to Treasurer, Oconee County Habitat for Humanity, P.O. Box 685, Seneca, SC 29679

CHECKLIST (Place checkmark next to each number/letter when completed):

- 1. I have read and understand the above Information and Instruction.
- 2. I understand that the funds being distributed are being provided on a discretionary basis as such:
 - a. Although the funds are available this term they may not be available in the future.
 - b. The providing of these funds is the decision of an Educational Committee based on the rules that have been provided.
 - c. Granting of the monies available will be based on all the instructions stated above and the individual's ability to fill out and provide the appropriate documentation for these forms.
- 3. I have filled out <u>completely</u> and attached the following forms and documents:
 - a. Request Form.
 - b. Detailed Expense Sheet.
 - c. Checklist (this document).
 - d. If you previously received educational funds, submit a transcript of the courses taken and the grades received.
